

## WELCOME TO LAKE JELEŃ!

## JELEŃ LAKE REGULATIONS

### IMPORTANT INFORMATION

- 1) Fishing at Jeleń Lake within the Jeleń Resort & SPA complex is permitted only after paying a fishing fee (does not apply to hotel guests).
- 2) The lake is open daily, 24 hours a day, except during the period when the lake is frozen and during periods when the resort is closed.
- 3) Permitted fishing methods include: ground fishing, float fishing, feeder fishing, method feeder fishing, spinning (from the shore and from boats), and carp fishing.
- 4) A set may be equipped with a maximum of one hook. For spinning, the use of one anchor or two anchors (wobbler lure) is permitted.
- 5) The maximum number of rods per angler is:
  - 2 rods
  - for carp fishing, a third rod is allowed for an additional fee
  - for spinning, the use of one rod is allowed. Spinning from personal boats is only allowed after prior agreement with a supervisor (strictly electric motors). Anglers must wear a life jacket while fishing. Be careful not to obstruct shore anglers..

### FEES

- 6) The fishing fee is:
  - Daily fee - 50 PLN
  - Weekly fee - 250 PLN
  - Annual fee (maximum 40 permits) - 600 PLN
  - Surcharge for the third carp rod - 20 PLN / day
  - Fee for organizing competitions determined individually based on the number of participants, duration, etc.

- Guests staying at the resort accommodations after obtaining the appropriate badge - free of charge
  - Children up to 12 years old can fish within the adult's rod limit without additional fees. The presence of minors on the fishing ground is only possible with an adult who is responsible for them.
  - There is a 10% discount on permits for holders of a valid Fishing VIP card.
- 7) The confirmation of the fishing fee must be carried and presented upon request by the permit controller.

### FISH SAFETY

- 8) When fishing with **ground, float, and feeder methods**, the angler must possess and use:
- Mat
  - Landing net
  - Disgorger
  - Barbless hooks (Method Feeder)

For **carp fishing**, the angler must possess and use:

- carp cradle or thick mat (preferably with sides)
- carp landing net
- Disgorger
- Barbless hooks

For **spinning**, the angler must possess and use:

- Landing net
- Pliers / forceps for safely unhooking fish

- 9) The "NO KILL" principle ("catch and release") applies to ALL fish species in the lake.
- 10) Please handle the fish gently. Photographing should be done in a position safe for the fish, e.g., over a mat, in the water, etc. Not standing up!
- 11) It is recommended to use a disinfectant, especially in the case of visible abrasions or injuries to the fish.

- 12) In the event of catching a diseased fish, the supervisor / owner of the lake must be notified immediately. Such fish must not be released back into the water before inspection by the aforementioned persons.
- 13) It is prohibited to kill and take away fish under penalty of a financial fine, which amounts to 500 PLN per fish in the case of theft / poaching or in the case of fish over 5 kg per kilogram. Additionally, such individuals will receive a lifelong ban from using the fishing ground.
- 14) The entire area is fenced and monitored around the clock.
- 15) In case of suspicion of theft / poaching, the supervisor or designated person has the right to conduct inspections, including checking bags, backpacks, or vehicles. Starting fishing implies acceptance of the regulations and consent to possible inspection.

### **PROHIBITED ACTIONS**

- 16) It is forbidden to possess and keep fish in fishing nets or carp sacks. If you wish to record material or take photos promoting the angler or the resort, you must obtain additional permission from the supervisor to use the net / sack. Upon receipt of the permission, anglers are required to tag and mention the Jeleń fishing ground on social media or their material. Fishing nets are allowed for fishing competitions, their minimum length is 3.5 m. A carp bag is also allowed at events, but it must be large enough not to endanger the fish's safety.
- 17) It is forbidden to lay fish on grass, sand, or soil.
- 18) It is forbidden to leave fishing rods unattended.
- 19) It is forbidden to fish using live or dead fish or their parts as bait. This also applies to the use of herrings (regardless of whether in oil or own juice) and ham.
- 20) The fishing ground must be kept clean. All waste must be taken away after fishing. Leaving bags of rubbish or nets is also prohibited. It is also forbidden to throw cigarette butts into the water or on the ground!
- 21) It is forbidden to interfere with the shoreline and damage it, as well as to destroy shoreline vegetation.
- 22) Lighting fires outside designated areas (shelter by the water) is prohibited.

### **GOOD PRACTICES WE EXPECT**

- 23) Vehicles may be parked at the fishing spot at a safe distance from the water. Especially after rainfall, park as close to the road as possible without obstructing traffic. Driving with a car on the fishing ground must be done safely for other people on the site.
- 24) The use of RC models and the transport of sets are allowed, but should not obstruct other anglers. Sets may be transported to the opposite bank, but if this spot gets occupied by another angler, the sets must be moved.
- 25) Please maintain silence, politeness, and good manners at the fishing ground. Persons who violate these rules and /or are under significant alcohol or drug influence will be expelled from the fishing ground without the possibility of refund!
- 26) In case of a storm, fishing rods must not remain in the water. They must be retracted and secured. Please follow safety regulations during fishing.
- 27) Pets are welcome, but you must clean up after them! You must also ensure the safety and comfort of other resort guests.

### **OTHER ISSUES**

- 28) It is possible to pitch a tent, arrive with a trailer, or camper.
- 29) The owner of the lake is not responsible for accidents and items left at the fishing ground.
- 30) Anglers are obliged to read the regulations. Entry onto the fishing ground and starting fishing is synonymous with acceptance of these regulations. Persons fishing without a permit or violating the regulations will be expelled from the fishing ground. In the event of the lack of a permit, an additional fee of 500 PLN will be charged.
- 31) Anglers, by accepting the regulations, automatically consent to the use of their image for marketing purposes, including on the Lake's website, Resort, Facebook, events held at the fishing ground, or among partners.
- 32) Issues not covered in the regulations should be discussed with the water supervisor.
- 33) The manager of the lake may change the regulations at any time, close the water for the duration of competitions, or for other reasons. The above information will be published on the Lake's Facebook fan page.
- 34) Persons authorized to conduct controls will identify themselves with controller cards.
